The Society's photograph LP 0277 of cyclists at the Clock Tower, North Street, as printed in the Leatherhead Advertiser, was of interest to two readers - one of whom was Mr L Bowerman, of the Send & Ripley History Society, and also President of the Veteran Cycle Club. He dates the photo at 1910-1912. This correspondence is entered as LX 879.

One article describes a planned "London to Bristol and Back in 24 Hours" ride starting on a Saturday evening. First stop, Reading, 29 miles, for light supper; second Hungerford, 54 miles, for a more substantial meal; a sandwich halt near Chippenham; breakfast at Bristol 108 3/4 miles. The return involves a second breakfast at Devizes; light lunch at Hungerford; dinner at Reading, then London. Total mileage 219 1/2. Entrance fee 17/6d including all meals except sandwiches. A certificate for all who complete the ride within 24 hours. The ladies wear ankle length skirts and enormous hats; the gentlemen knickerbockers and caps; and all have very upright cycles. How did they do it?

WINTER IN THE MUSEUM

After over two thousand visitors had been to the Museum in the 1994 season, the Curator closed the Museum just before Christmas and began three months of intense activity before it opens again in April. She has plans firstly for re-arranging the administration office so that she and the Secretary can work more efficiently together; and secondly, for new displays - Ronsons and Marie Stopes are two of them. The late Chairman of the Friends, Jim Middlemas, very kindly left the Friends £200 in his Will: much thought is going into the best use for it, but it is hoped to obtain some new display cabinets later in the year, so that small, valuable objects can safely be put on show. Improvements are planned to various artefacts in the museum: for instance, the painting of Mickleham Church is to be cleaned and the frame renewed.

MUSEUM STEWARDS

An enthusiastic group of Museum Stewards continued their duties from April to December 1994 - and the Society and the Friends of the Museum combined to thank them at a reception given in December 1994 at the Institute. However, more volunteers are always needed: if you can spare a regular three hours on Thursday afternoon, Friday morning or morning or afternoon on Saturday, the Curator, Janet Goldsmith, would be glad to know: Ashted 277611.

MUSEUM "WORKING PARTY"

In the November 1994 Newsletter, Geoff Hayward appealed for members to form a permanent working party, such as existed in the early days of the Museum. Brian Bouchard and John Wall volunteered immediately. The Trustees have been busy applying wood preserver to the timbers and painting the walls of the outside of Hampton Cottage; the two extra pairs of hands were very welcome.

MINUTES OF THE 47TH ANNUAL GENERAL MEETING HELD IN THE DIXON HALL, LEATHERHEAD INSTITUTE, AT 8PM ON FRIDAY, 15 APRIL 1994

62 Members of the Society

Before the formal business of the meeting, Mr Fortescue commented on the year's work. Invidious as it could be to pick out any particular person or activity, he felt he must mention the high quality of the Proceedings since its beginning; the present Editor, Jack Stuttard, had even improved the standard over recent years. Also, the Museum, which is slowly becoming a focal point for local historians. The good work started by David Bruce is being continued by Janet Goldsmith, who, of course, adds the feminine touch to the displays and the building itself. The problem of storage continues to grow. Space has been found in The Priory, The Institute, Wesley House and the Public Library, mainly through the efforts of the Chairman. Mrs Heath was unstoppable in doing anything to further the cause of the Society - hence the success and respect it enjoys. There are nearly 400 members, which is remarkable for a local learned Society.

Mr Fortescue said his personal dream since Hampton Cottage came into being, was that the Society should have its own premises for storage and perhaps research. A wealthy benefactor was needed!

2. MINUTES OF LAST MEETING

The acceptance of the Minutes of the 46th Annual General Meeting held on Friday, 19 March 1993, was proposed, seconded and agreed.

3. MATTERS ARISING FROM THE MINUTES - None

4. EXECUTIVE COMMITTEE REPORT FOR 1993/4

Mrs Heath introduced this report. She expressed thanks to all the Society's members for their interest and help; to Mrs Eileen Smith and her coffee team for providing refreshments at the monthly meetings; Stephen Fortescue for his advice and assistance to her; and all members of the Committee - it was good to see the Secretary back after her recent time in hospital.

The adoption of the Executive Committee Report was proposed, seconded and agreed.

5. SOCIETY'S ACCOUNTS FOR YEAR TO 31 DECEMBER 1993

Mr Latham commented on certain items in the accounts, such as the decrease in interest received, the increase in the cost of insurance, and the small surplus from meetings compared with 1992 which was a Mole Valley Festival Year. He also reminded the meeting that in 1992 the Society had taken over the running of the Museum, which had made a difference to the figures for 1993.

The adoption of the accounts was proposed, seconded and agreed.

6. APPOINTMENT OF HON AUDITOR

The Treasurer thanked Mr Kirkby for his work for the Society in the past year, and said that he was willing to continue as Auditor.

Mr Kirkby's appointment was proposed, seconded and agreed.

7. TRUSTEES ACCOUNTS FOR THE YEAR TO 30 SEPTEMBER 1993

In the absence of Mr J R Bull, Mr D Bruce commented on these accounts. He mentioned that the Trustees are intending to repair the front elevation of Hampton Cottage.

8. SUBSCRIPTION FOR 1995

No increase in the subscription was necessary.

9. ELECTION OF EXECUTIVE COMMITTEE

All Officers of the Committee were willing to continue. As there were no new nominations, their re-election was proposed, seconded and agreed. Of the Committee Members, Mr David Ellis wished to resign, but would continue his present work on Sub-Committees. Mr Knowles was willing to continue, and two new Committee members - Mrs J Godfrey and Mr P A Tarplee - had been nominated. It was proposed, seconded and agreed to re-elect Mr Knowles and to elect Mrs Godfrey and Mr Tarplee.

10. ANY OTHER BUSINESS - None

There being no further business to discuss, Mr Fortescue thanked members for attending, and closed the meeting at 8.20pm.

EXECUTIVE COMMITTEE REPORT OF THE SOCIETY'S ACTIVITIES
DURING 1994

1. EXECUTIVE COMMITTEE

This report is presented by the Executive Committee elected at the Annual General Meeting on 14 April 1994. Mr A Tuffery was later co-opted by the Executive Committee. A full list of the Committee is given in the 1994 Proceedings.

2. MEMBERSHIP

Jim Middlemas and Michael Gale

June sadly saw the passing of Jim Middlemas and Michael Gale, two of the Society's most active members.

"Honours" - During the year, three members were "honoured" for their work in various fields:

- Chris Latham, the Society's Treasurer, was appointed Master of the Worshipful Company of Cutlers
- Ernest Crossland was appointed an Honorary Vice-President of the Surrey Archaeological Society in recognition of his many years of archaeological work.
- Maurice Exwood was elected a Fellow of the Royal Historical Society: he used some of his articles published in the Proceedings as part of his submission for Fellowship.

Subscriptions

From 1 January 1994, subscriptions were raised from £6 to £8 for single membership, and from £9 to £12 husband and Wife, Juniors 18 years and under remaining at £1.

PROGRAMME

A programme of lectures and visits was arranged during 1994, including three lectures presented as part of the Mole Valley

Festival of Arts. A full list of the year's events is contained in the 1994 Proceedings.

4. PUBLICATIONS

Proceedings - Volume 5, No 6 dated 1993, was published in February 1994.

Ashtead History - The Editor and a team of researchers continued work on the new Ashtead History. Drafts are now being made ready to go to print early in 1995. Illustrations have been selected, and a possible printer interviewed.

Fetcham History - Mr G Hayward and Mr J G W Lewarne have continued their work on this publication.

History of Leatherhead - A Town at the Crossroads - Now practically out of print but the Society still has a few copies for sale. It is not intended to reprint until some time after the Ashtead History has been produced

5. RECORDS

The process of making a central register of all the Society's records continues: with the listing of photographs and pictures of Leatherhead, the major part of the task has been completed.

Over the 50-year history of the Society, the volume of records has steadily increased. Items come from varying sources, often via the Museum, thus enabling Parish Archivists to answer questions from our own members as well as the public, recently including members of the Dallaway family.

Some of the records held in the Leatherhead Public Library's local history section, have been listed by the Records Secretary. The list is now in the Society's records, as well as being with the Public Library.

David Bruce, a former Records Secretary, and Bookham Archivist for many years, is leaving the district. Brian Godfrey succeeds him as Bookham Archivist: he is gradually taking over.

Jack Willis and Geoff Hayward continued their work as Archivists for the Parishes of Ashtead and Fetcham respectively. The Records Secretary himself deals with the Leatherhead Records.

Material has been exchanged with the Dorking Society, with whom this Society is now in close touch.

6. ARCHAEOLOGY

Hampton Cottage Well

A small team led by Ernest Crossland continued excavation work on the well but in November 1994 when a depth of about 30 feet had been reached, it was decided to abandon the project. An appropriate cover will be obtained both for safety and protection of the well itself.

7. MUSEUM

The Curator has continued to be supported by the Museum Sub-Committee, which includes a representative of the Trustees.

The Museum was open from 2 April to 17 December 1994, on Thursday afternoons, Friday mornings and all day Saturday. The estimated number of visitors during that time was 2,150 including 350 children, an increase of 13 percent on 1993. The European Heritage Week-end of 10 and 11 September was particularly successful, with some 150 visitors in the two days.

The Museum, with help from the four Parish Archivists, continued to deal with many enquiries, particularly on local houses and family history.

The Trustees of the Museum have recently treated the woodwork and painted the walls of the outside of the Museum, as well as doing some repair work. They were helped by Brian Bouchard and John Wall who answered an appeal for members to form a permanent team to deal with decorations and small repairs.

Stewards - A dedicated group of Stewards continued their duties during the times the Museum was open, but more Stewards are needed and volunteers would be most welcome. The Society and the Friends of the Museum jointly gave a reception in the Institute in December 1994 to thank the Stewards and other helpers.

8. SALES

Society - Sales of the Society's publications continued during the year, both at the Museum and at monthly meetings and outside displays.

Friends of the Museum - The "Friends" produced a "Museum" tea-towel which has proved very popular. The first batch of 106 was nearly sold out by Christmas. The Hume Fund as been used to finance the production of three postcards for sale at the Museum - Leatherhead Bridge 1832, Thorncroft Manor 1842, and the Running Horse Inn c.1900. All the cards are selling well.

9. TALKS BY THE SOCIETY

Speakers - All requests from other organisations for speakers on historical subjects, were answered this year. But there

is a great shortage of such speakers and volunteers are urgently needed.

Slides - The Society's collection of slides is kept by the Lecture Secretary, Norman West, and a selection of those of Fetcham were presented by Geoff Hayward during the winter programme.

10. SOCIETY'S LIBRARY

The Trustees of the Leatherhead Institute are for the time being, leaving their Library intact, which means that the Society can continue to house its own library there. The Society's Librarian, Frank Kirby, produced a new list of the Library's publications: this is available for reference in the Library itself.

The Institute Trustees have given the Society the free use of the Library room every week-day afternoon for meetings and research. Much use has been made of the room and the Society is grateful to the Institute Trustees for allowing the arrangement to continue.

11. JOSEPH PAYNE

Following a suggestion from this Society Surrey County Council arranged for the new Reading Room in Leatherhead Public Library to be named after Joseph Payne who founded the Mansion Grammar School in 1845.

12. ST GILES' CHURCH, ASHTEAD

Restoration work in 1994 on St Giles' Church, Ashtead provided a unique opportunity to study the structure of the building from the scaffolding. A small team, led by Howard Davies, worked extensively on the project under the auspices of this Society.

Research material will take time to be analysed and interpreted but in due course there will be an exhibition of photographs, drawings and diagrams.

The Society has undertaken to fund part of the work.

The Committee wishes to thank all members for their interest and support. They are the only people who can continue to make the Society and the Museum such a success.
